Entry Fees:

Spectators: \$6.00 admission **per day**. Spectators will receive a wristband each day which will need to be presented for entry. All coaches, wrestlers, and managers must either be stamped, have a wristband, or pay to get in.

Concessions: Full concessions will be available both Friday and Saturday.

Coaches Hospitality: Coaches will be provided with a hospitality room. A wristband will be needed to enter. Coaches, officials, table workers and volunteers only.

Team Tables: Team tables will be set up in the cafeteria. **No coolers will be allowed in either gym.** We will also have specified bleachers for teams. This will be for wrestlers and coaches only.

NOTE: Coaches, as this will be a big event, we will have mats roped off for coaches and wrestlers only. Please be aware only coaches with wristbands will be allowed beyond the ropes.

Team: Team fees are paid to the High School League (reference SCHSL Handbook).

All AA Schools will be permitted to enter one competitor in each weight class at the Upper and Lower State Qualifying Tournament.

It will be a 16 man double elimination bracket using single elimination wrestle-in matches to set the 16 man bracket.

Seeding meetings for the Upper and Lower State Individual Qualifiers will be held on February 13.

Time to be determined by host teams. All wrestler records and information needs to be submitted to the host school by 9:00 AM on February 13.

Individual Tournament Seeding Criteria: All wrestlers will need a 10 match minimum to be seeded.

Wrestlers without a 10 match minimum will be a random draw. A wrestler MAY NOT carry a record up, but MUST take record down. Initial Seeding will be based on Overall Winning Percentage.

Head to Head Trumps Overall Winning Percentage

In the event of a tie, the criteria will be as follows:

- Previous State Placer
- Previous State Qualifier
- Overall Consensus of Seed Committee
