REGULATIONS

1. The host school will prohibit the use of loud noisemakers such as cowbells, air horns, megaphones, and musical instruments. The tournament director will forbid noisemakers during tournament play. SIGNS (with the exception of welcome signs) WILL NOT BE PERMITTED BEYOND REGION PLAY.
2. When tri-matches are played, the two visiting teams should play first (the home team should be ready to play at match time in the event one of the scheduled teams is not present and ready to play). The loser then plays the home team and the winner of the first match will play the home team in the final match. Exceptions are allowed for travel time purposes. (It may be helpful for the team with the furthest travel to play in the first two matches).
3. In single matches and in the first match of a tri-match, teams will be given six minutes separately on the court to warm-up. The team designated as the home team will have the first warm-up period. In the second and third matches of a tri-match, teams having already played will be given 3 minutes (3-3) separately to warm-up. The team having just played in the previous match will warm-up second and their opponent will warm-up first.
4. During regular season and tournament play, a team that has not arrived at the playing site and ready to play at the scheduled time will forfeit its initial set. If the team has not arrived within 30 minutes after the scheduled starting time, the match will be forfeited. For 3 out of 5 matches, wait an additional 15 minutes.
5. During the season when rescheduling occurs and teams are added or dropped, notify your district director as well as the other team(s) involved. Refer to page 93 in Rules and Regulation's section of the SCHSL handbook.
6. Teams are reminded to go directly to your position after shaking hands to begin a match.
7. Teams are required to wear their regular jersey starting at the call of the captains/coaches meeting.
8. Each team shall be responsible for providing and training at least one line judge for each match played. It is strongly recommended that adults be used. If players are used, they may not be dressed in their team uniform. Both schools will provide a line judge. If the visiting team does not have a line judge, they forfeit this right and the home school will provide a second line judge.
9. All matches must start on time based on the listing time in Arbiter. This is very important as far as the public and game officials are concerned. Officials are not expected to help set up the court.
10. Officials who do not report to the match site at least thirty minutes before starting time should be reported in writing to the South Carolina High School League Office and your director.
11. A 3 OUT OF 5 MATCH MAY ONLY BE PLAYED WHEN ONLY TWO SCHOOLS ARE INVOLVED IN A SINGLE MATCH.
12. So that officials can hear the contact of the serve and in order to detect overlapping, there should be no noise by team personnel during the serve. To promote sportsmanship fans are expected to follow the same protocol.

RESPONSIBILITIES OF OFFICIALS

Officials are reminded to:

1. Keep a current and correct preferred mailing address and home, business and cell phone numbers on file in the Arbiter. (www.arbitersports.com)
2. Check and update Arbiter daily.
3. During the volleyball season, an official must report any irregular procedure of the match or any unusual conduct on the part of the crowd, players, school officials or students to their director and the South Carolina High School League Office. This includes instances such as a team walking off the court and refusing to play, disqualifications (players and coaches), other unsportsmanlike acts, inadequate court markings, etc.
4. Leave the volleyball court at the completion of the match.

OFFICIALS UNIFORM

The South Carolina High School League requires that officials wear an official SCHSL volleyball shirt; black slacks (not cords, jeans, spandex or cargo shorts); black gym shoes and socks. Shorts are permissible through regular season. Officials must be dressed alike.

For the 2019 season only, an official may wear a solid white polo without a logo, pocket or piping. This will only be allowed during the regular season. Play-off officials must be in the veteran officials shirt with SCHSL logo

LINE JUDGES

Good line judges are essential for a volleyball match. Poor line judges put both teams at a disadvantage. **It is the school's responsibility to select, instruct and train line judges.** Well in advance of the beginning of the volleyball season, school personnel should recruit and select line judges (**preferably adults**) who are willing to volunteer their time and services. Paying line judges will not solve the problem of the need for better line judges. Proper instruction and training will! The line judge must be able to ignore spectator criticism and maintain complete concentration on the game.

It is impossible for the R1 to instruct and train line judges in the short time allotted just prior to a match. Time permits only a brief, general review of their duties and responsibilities.

Coaches should communicate to players and fans the fact that line judges are assistant officials. They **assist** the R1 but do not make decisions. As the head official, the R1 makes all decisions. The R1 merely considers the calls made by the line judges. The R1 may overrule a line judge's call at any time. **It is highly required that line judges use red flags.**

Characteristics of a Good Line Judge:

1. Reports to the R1 no less than 20 minutes before the scheduled starting time of the match.
2. Reports promptly to the prematch meeting with the officials.
3. Is properly instructed and trained in all duties and responsibilities.
4. Performs duties in a confident, quiet, efficient manner.
5. Is appropriately dressed.
6. Is always courteous to other line judges, officials, coaches and players.
7. Is cooperative and responds in a positive manner to suggestions and directions from the R1.
8. Remains aloof from players and spectators during the match.
9. Refrains from reacting as a spectator to anything that occurs during the match.
10. Makes objective calls that are both quick and decisive, using the correct signals.
11. Concentrates on duties and responsibilities without distraction from other people.
12. Is always alert and ready to move quickly into the best position to make a call without interfering with play.
13. Shows respect for the calls of other line judges.
14. Shows respect for and accepts, without question, all decisions of the R1.

General Guidelines:

1. Line judges are assigned their positions by the R1.
2. Line judges shall hold these same positions relative to the court throughout the match.
3. Line judges are to make calls for balls landing on or near the sideline and end line closest to them prior to retrieving the ball.
4. In general, a line judge should be in a position near the intersection of the sideline and the end line.
5. Line judges **MUST MOVE** to be in the best position for an unobstructed view to make the call.
6. Line judges never enter the playing area.
7. Line judges must be alert to avoid being struck by the ball or interfering with a player's opportunity to make a play.

Specific Duties (Rule 5) - Line judges shall:

1. Determine at the moment of contact for the serve whether the server touches the end line or the floor outside the lines marking the width of the serving area.
2. Indicate when the serve, or any played ball, crosses the net not entirely between the net antennas.
3. Indicate when the ball touches the net and/or net supports not entirely between the net antennas.
4. Indicate whether a ball is in bounds or out-of-bounds when it lands near any line for which the line judge is responsible.
5. Indicate when a player touches a ball that is going out-of-bounds on the player's side of the net.

2020-21 VOLLEYBALL MAJOR RULES CHANGES

4-1-4 (NEW): Allows the use of a molded protective face mask made of hard material during play.

7-1-1; 7-1-1 PENALTIES; 7-1-1 PENALTIES 2 (NEW); 9-9-1a (NEW); 10-3-7b: Eliminates the loss of rally/point penalty for failure to submit the team roster during the prematch conference and replaces the penalty with an unnecessary delay (administrative yellow card).

7-1-4a(1) & (2) NEW: Allows a team to correct a submitted lineup if it lists a libero number that no team member is wearing.

12-2-6: Establishes that a yellow card issued for unsporting conduct to the head coach, assistant coach(es) or team bench will no longer require the head coach to remain seated, while maintaining that a red unsporting conduct card will require the head coach to remain seated for the remainder of the match.

Official Signal #15: Establishes that an official will rotate their forearms around each other with closed hands to signal substitution.

2020-21 Volleyball Rules Considerations

In support of the Guidance for Opening Up High School Athletics and Activities, the NFHS Volleyball Rules Committee offers this document for state associations to consider whether any possible rules could be altered for the 2020-21 season. The considerations outlined in this document are meant to decrease potential exposure to respiratory droplets by encouraging social distancing, limiting participation in administrative tasks to essential personnel and allowing for appropriate protective equipment.

Return to Competition

1. Volleyball Rules Considerations

- ***Prematch Conference (1-2-4a; 1-6-2; 1-6-3; 2-1-10; 5-4-1h, k; 5-6-1; 7-1-1; 7-1-1 PENALTIES 1; 9-1a; 12-2-3)***
 - Limit attendees to one coach from each team, first referee and second referee.
 - Move the location of the prematch conference to center court with one coach and one referee positioned on each side of the net. All four individuals maintain a social distance of 3 to 6 feet.
 - Suspend the use of the coin toss to determine serve/receive. The visiting team will serve first in set 1 and alternate first serve for the remaining non-deciding sets.
 - Suspend roster submission at the prematch conference. Rosters are submitted directly to the officials' table before the 10-minute mark.

- ***Team Benches (5-4-4b, 9-1-2, 9-1-2 NOTE, 9-3-3b)***
 - Suspend the protocol of teams switching benches between sets. In the event there is a clear and distinct disadvantage, teams may switch sides, observing all social distancing protocols. Officials will determine if a disadvantage is present.
 - Limit bench personnel to observe social distancing of 3 to 6 feet.

- ***Deciding Set Procedures [1-2-4b, 5-4-4c, 5-5-3b(26), 9-2-3c]***
 - Move the location of the deciding set coin toss to center court with team captains and the second referee maintaining the appropriate social distance of 3 to 6 feet. A coin toss, called by the home team, will decide serve/receive.
 - Suspend the protocol of teams switching benches before a deciding set. In the event there is a clear and distinct disadvantage, teams may switch sides, observing all social distancing protocols. Officials will determine if a disadvantage is present.

- ***Substitution Procedures (2-1-7, 10-2-1, 10-2-3, 10-2-4)***

- Maintain social distancing of 3 to 6 feet between the second referee and the player and substitute by encouraging substitutions to occur within the substitution zone closer to the attack line.
- **Officials Table (3-4)**
 - Limit to essential personnel which includes home team scorer, libero tracker and timer with a recommend distance of 3 to 6 feet between individuals. Visiting team personnel (scorer, statisticians, etc.) are not deemed essential personnel and will need to find an alternative location.

2. Volleyball Officials Manual Considerations

- **Pre and Post Match Ceremony**
 - Establish volleyball specific social distancing match protocols including the elimination of handshakes before and after the match.

3. Volleyball Rules Interpretations

- **Rule 4-1 EQUIPMENT AND ACCESSORIES**
 - Cloth face coverings are permissible. (4-1-4)
 - Gloves are permissible. (4-1-1)
- **Rule 4-2 LEGAL UNIFORM**
 - Long sleeves are permissible. (4-2-1)
 - Long pants are permissible. [4-2-1i (1)]
 - Under garments are permissible, but must be unadorned and of a single, solid color similar in color to the predominant color of the uniform top or bottom. [4-2-1h (3), 4-2-1i (2)]
- **Rule 5-3 OFFICIALS UNIFORM AND EQUIPMENT**
 - By state association adoption, long-sleeved, all-white collared polo shirt/sweater are permissible. (5-3-1 NOTES 2)
 - Electronic whistles are permissible. (5-3-2a, b)
 - Cloth face coverings are permissible.
 - Gloves are permissible.

In addition to the NFHS rules considerations, the S.C. High School League will use the following protocols for game day.

○ **Team Benches**

- Consideration should be given to spacing in the bench areas. If possible, allow for extra chairs to be used in between players and coaches.
- Face coverings are recommended for players in the bench area.

○ **Face Coverings**

- Face coverings should be a solid color. School logo face coverings are allowed.

○ **Balls**

- Each team will be responsible for providing their own balls for warm up. Teams will not shag balls for each other.
- Home team will need to have 3 game balls for the match.
- Game balls will need to clean throughout match. Assign people to do this during the match. (Does not have to occur after each rally)

○ **Water/Towels**

- Visiting team will need to bring water.
- Players should bring their own towel if needed.

○ **Locker Rooms**

- Teams should be dressed upon arrival.

○ **Coaches**

- Communication between coaches is extremely important. Please talk the day before your match to discuss procedures with visiting team.
- Have hand sanitizer readily available at scores table and recommended for each bench area.
- Practice with your players substitution protocol at the attack line.

- Practice with your players eliminating huddles after rallies. You are going to have retrain them with how to cheer.
