Last week during one of the member schools’ contests, there was another first this sports season in unsportsmanlike behavior. During a contest, a spectator came onto the field of play and made contact with one of the competing athletes on the opposing team. While enthusiasm and support for your local team are encouraged, actions such as this are never warranted or acceptable. Luckily the school’s administration addressed the situation promptly. We must continue to communicate and stress the expectation of good sportsmanlike behavior by all in attendance at the contest – the athletes, the coaches and staff, the game officials, and the spectators.

As an update, last week 15 schools had players ejected for unsportsmanlike behavior and 2 schools had a spectator removed from the facility for unsportsmanlike behavior.

Congratulations to the many schools that competed last week with no ejections due to unsportsmanlike behavior. For the few schools that did not meet the goal, let’s continue to work toward this goal.
