This correspondence comes to you as information. The South Carolina Senate Education Subcommittee is scheduled to meet Wednesday, March 27, 2024, at 10:00 am in the Gressette Building, Room 105 (see attached agenda).

During this meeting, three proposed Bills will be discussed and possibly voted upon. These Bills, if passed (individually or collectively), will have a direct impact on the governance and operations of the South Carolina High School League. Bills S.150 and S.161 speak to private schools student athletes participating on public schools teams. Bill S.1173 speaks to students transfer and eligibility, use of names, image, and likeness (NIL) by student athletes, the creation of an appeal panel, and the authority of the State Department of Education.
