ACTIVITIES:

Proposal 1:

The SCTCCCA is proposing that the start of the track season (competition)begins one week earlier, and the state track meet be held one week earlier. **APPROVED**

Proposal 2:

Proposal SCHSSCA would like to extend their playoffs season by one week, allowing soccer to have three weeks of playoffs compared to the two they have now. **APPROVED**

Proposal 3:

Proposal the SCFCA for players to have the option to play in four quarters split over a two-day period. Two quarters would be at the Sub-varsity level and two would be the following night on the varsity level.

Proposal 4:

Proposal from the SCFCA for schools to be required to track and input Empirical Medical Data for collection and tracking of injuries for use in implementing rules, regulations, and policies. **NOT APPROVED**

Proposal 5:

Proposal from the SCWCA to move the wrestling dual finals one week earlier and to move the state wrestling individual championships up one week as well. This proposal also includes expanding the number of qualifiers for the individual finals from eight to sixteen per classification. **APPROVED**

Proposal 6:

Proposal by North Central High School to require spring sports playoff games to be completed in their entirety if weather causes the contest to be ended. **NOT APPROVED**

Proposal 7:

Proposal by the league office to require all state championship finals between two schools (series in baseball and softball) to be played to completion of the contest, unless both schools agree to end the contest earlier. **APPROVED**

Proposal 8:

Proposal by James F. Byrnes High School to allow for the shot clock in varsity basketball to be used in tournaments, invitationals, showcases and non-region games (where both schools agree) for the 2024/25 and 2025/26 seasons and in the school, year beginning in 2026/27 requiring that Class 5A and Class 4A use the shot clocks in all regular season and playoff games. APPROVED (Omit year beginning in 2026/2027 requiring that Class 5A and Class 4A use the shot clocks in all regular season and playoff games)
