# STAY ON THE BENCH!!

After just one week of football, we've seen approximately 28 ejections, most due to physical violence. This is a concerning trend, and we urge each of our member schools to actively educate both student-athletes and coaches on the importance of maintaining composure during games.

One area that needs immediate attention is the number of student-athletes leaving the bench to join heated situations on the field. To address this, we recommend implementing specific drills that reinforce the importance of staying put. Use code phrases like "stay in place" or "take a seat" to remind players of their responsibility to remain on the bench during altercations.

It is crucial to emphasize that coaches and officials are the ones responsible for handling conflicts. When players leave the bench to get involved, it not only escalates the situation but also results in severe consequences, including ejection and suspensions.

By consistently reinforcing these guidelines and practicing these drills, we can work together to reduce ejections and maintain the integrity of our games. Let's make it clear: staying on the bench is not just about following the rules—it's about ensuring the safety and sportsmanship of everyone involved.

As we start the new school year, there are already fake SCHSL social media pages circulating, and fake companies pretending to be the broadcast partners of the SCHSL.

The first column for the 2024-25 school year provides vital information about the **official** social media accounts and **official** broadcast partner of the SCHSL.

Below is a graphic with the **official SCHSL social media pages**. All other pages using the SCHSL logo or anything similar, are unofficial, and the South Carolina High School League highly suggests unfollowing and discourages following them.

Please note, SCHSL uses  as the profile picture on its official Facebook, and official X (formerly Twitter) page and Instagram uses  as the profile picture on the SCHSL official page.

Additionally, the SCHSL has only **ONE** official network that broadcasts its events, [www.nfhsnetwork.com](http://www.nfhsnetwork.com). In the event you receive an email or social media graphic with the opportunity to order an event from one of the fake pages offers, **DO NOT CLICK THE LINK**, it is a **fraudulent link** that aims to obtain your personal information (i.e., credit card information, debit card, etc.).

## 2024-25 League Pass

### Superintendents and Principals

We have received many emails regarding the link to upload the photo to the pass. The link will only work if you already have a pass. It does not request the pass for you.

Information pertaining to the process for applying for SCHSL passes was sent via e-mail from the Director of Technology on August 9, 2024. Please refer to the email as it contains important information about the process.

The Magic Link is a way to verify your identity without having to create an account and password. It's a shortcut.

**Below is the process for obtaining the 2024-25 passes:**

1. Superintendent or Principal fills out a Cognito form containing each person who will receive a pass.
2. Data is uploaded into Cuseum's database.
3. Emails are sent to each recipient listed on Cognito form with download instructions.
4. Once you download the Pass, the Pass recipient can upload their photo using the photo upload link.

- The email with the pass download instructions will come from [membership@cuseum.com](mailto:membership@cuseum.com).
- The email with the magic link will come from [memberportal@cuseum.com](mailto:memberportal@cuseum.com).

**Retiree Passes:** We are in the process of converting to a new digital system. Individuals needing a retiree pass should fill out the High School League pass request form. Once the system conversion is complete, the applications will be processed, and the instructions to download the Retiree Pass will be emailed.

## The Health Spot

Tragically, an Alabama high school football player passed away after sustaining a head injury during a football game last Friday. Although the exact cause of death is unknown at this time, let this incident serve as a reminder to make sure we are diligent with recognizing the signs and symptoms of a suspected concussion.

In the worst case scenario, an athlete may develop second impact syndrome where they sustain a second concussion before the original one has healed. This second impact can cause rapid and severe brain swelling, leading to catastrophic consequences such as brain damage, permanent disability, or even death.

It is imperative that an athlete who exhibits and/or reports any signs of a concussion be evaluated by an appropriate health care professional before returning to play. For more information on concussions and second impact syndrome visit the CDC website below:

## Officials' Whistle

### NFHS OFFICIAL'S CODE OF ETHICS

Officials are the unsung heroes of our high school athletic contests. They uphold the integrity of the sports they officiate and help to provide a safe environment for our student-athletes to play. Did you know they have a Code of Ethics that they use as the guide to perform the duties? Here are a few guidelines:

Officials shall master both the rules of the game and the mechanics necessary to enforce the rules, and shall exercise authority in an impartial, firm and controlled manner.

Officials shall uphold the honor and dignity of the profession in all interaction with student-athletes, coaches, athletic directors, school administrators, colleagues, and the public.

Officials shall, while enforcing the rules of play, remain aware of the inherent risk of injury that competition poses to student-athletes. Where appropriate, they shall inform event management of conditions or situations that appear unreasonably hazardous.
