FOOTBALL SEASON: Add one (1) Week to the regular season, four (4) rounds of the state

playoffs, and the State Finals date will be what we currently have,

December 5 - December 7, 2024 - FAILED

Add one (1) Week to the regular season, five (5) rounds of the state playoffs, and the State Finals will be December 12 – December 14,

2024 - **PASSED**

VOLLEYBALL SEASON: Add one (1) Week to the regular season, five (5) rounds of the state

playoffs, and the State Finals will be November 9, 2024 (Boys) and

November 14 and November 16, 2024 (Girls) - PASSED

MIDDLE SCHOOL VOLLEYBALL SEASON: - Extended to October 28, 2024 - PASSED

COMPETITIVE CHEER: All dates remain the same. Proposed to reduce the following

requirement to one (1) competition: Must have participated in at least two (2) regular season competitions in order to be eligible to participate

in the qualifiers – PASSED

TENNIS: Add one (1) Week to the regular season, five (5) rounds of the state

playoffs and the State Finals will be November 16, 2024 – **PASSED**

CROSS COUNTRY: All dates remain the same: Propose to reduce the following

requirement to one: All runners must have competed in a minimum of one (1) cross country races prior to entering state competition –

PASSED

SWIMMING: Dates for State Finals remain the same. Deadline for state qualifying

times was extended to October 9, 2024. This extended qualifying

opportunities for all swimmers.

GOLF: No change to qualifier dates or championship dates.

MIDDLE SCHOOL FOOTBALL SEASON: - Extended to November 14, 2024, but not to exceed the number of allowable contest - PASSED

Other Business:

Commissioner Singleton was granted permission by the Executive Committee to explore the services
of a Legislative Consultant Service. Two or three consultant services will present before the committee
